

## Summer Abroad COVID-19 FAQs

- Students must comply with [Tulane University's COVID-19 requirements](#) based on guidance from the CDC.
- Once you are enrolled as a Tulane student (around 1 month before the start of your program) you must submit the required documentation. You will be notified directly by [Tulane's Campus Health Department](#) to create a Campus Health Patient Portal, where you can submit the [necessary documentation](#).
- Students will be responsible for meeting each country's entry requirements for their program.
- Please see the specific COVID-19 travel and lodging guidelines (on page 2) for each of our program locations. These links are updated directly by each country, so it is important to continually monitor country requirements. It should be noted that regardless of vaccination status, many of the countries require completing additional documentation prior to arrival and/or proof of a negative COVID test.
- Students should be prepared to abide by all local and program health mandates regardless of vaccination status. Keep in mind that you are a guest in your host country and should be respectful of local communities by doing your part to help minimize the spread and impact of COVID-19. Students who are found in violation of program or local health mandates may be subject to disciplinary action upon return to Tulane or may be dismissed from the program.
- **Program Cancellation Due to COVID-19**  
In the event a program must be cancelled due to force majeure circumstances such as COVID-19, all monies (deposit, tuition, and housing) will be refunded.
