Subject: Notices of Intent to File Clean Water Act Suit Against Enterprise Products Operating LLC

Dear Mr. Schoeffler and Ms. Mitchell:

Enterprise Products Operating LLC has received your September 29, 2017 notices of intent to file a Clean Water Act citizen suit and addressing related matters in connection with our 65-mile, 10-inch RGP pipeline project. We appreciate your time in our teleconference on November 17, 2017 to discuss these issues.

This letter is intended to memorialize certain matters that Enterprise believes should be relevant to your clients' decision whether to file a Clean Water Act citizen suit against us.


In particular, we wish to inform you that the seven temporary "plug" locations identified in your respective letters have been removed. Enterprise therefore believes that the circumstances giving rise to your notices of intent to file suit have been remedied. Current pictures of the seven areas in question have been supplied by our environmental inspector for the pipeline project and are attached to this letter. In the event that other isolated areas or minor issues associated with the RGP pipeline project have not been resolved to your satisfaction, we anticipate that these concerns will be resolved in the near future as right-of-way restoration activities are concluded. We would encourage you and your clients to reevaluate the current status of the project area and contact us before any decision to file suit.

Enterprise takes environmental compliance and protection issues and your clients' concerns seriously. We believe that the circumstances noted in your letters were temporary and hope that this letter and our actions to clear the plugs and restore the right-of-way have satisfied

your concerns. However, please be advised that Enterprise intends to defend itself vigorously in the event that your clients choose to file suit.
